#### FINANCE—AN ADVANTAGEOUS TIME

\$13.245 million bond issue to pay project costs plus bonding costs of issuance and capitalized interest during construction.

**NOW** is considered an advantageous time for the bond issue because:

# 1. Interest rates, estimated at 2.75% for the 25-year bond, are near historically low levels, making the cost of repayment more affordable.

- 2. USD 332 has a large and growing tax base as the district's assessed valuation has grown by more than \$9.5 million (16.46%) in the last decade. The total assessed valuation is \$69,991,696.
- 3. To be conservative in our plan of finance, we have assumed future growth of only 1% thorough 2032 and only ½ of 1% thereafter.
- 4. USD 332 has no existing bonded indebtedness.
- 5. The USD 332 total mill rate at 36.486 mills is the lowest in our area and one of the lowest in the state of Kansas.
- 6. Proposed 2022 bonds are estimated to require at mil rate of 9.9 mills.
- 7. With bond approval and the estimated 9.9 mill increase, the District's total mill rate will still be one of the lowest of school districts in our area.
- A mill is \$1 of tax on each \$1,000 of assessed valuation of property in the District.
- 9. 2022 bonds will require estimated additional taxes on a \$75,000 home of \$85.44 per year or \$7.12 per month.
- 10. According to information from the four Counties (Kingman, Pratt, Harper and Barber) in which USD 332 has tax valuation, State Assessed Utilities pay more than 69% of our taxes and would pay approximately that percent of the proposed bond payments.

# BOND ISSUE TO ADDRESS EDUCATION AND FACILITY CHALLENGES

**On April 5<sup>th</sup>**, voters in USD 332 will go to the polls to decide if now is the right time to make needed improvements to education and support facilities in Cunningham—West Kingman County Schools. Last December, the Board of Education adopted a resolution scheduling the special election requesting the authority to issue no more than \$13,245,000 in tax-exempt general obligation bonds to finance the proposed projects.

USD 332 is unique in not having had a voted bond issue for improvements in many decades. It is also very unique in having the lowest total mill levy in the area and one of the lowest in the entire state of Kansas. With today's low interest rates and bond approval, USD 332 will still have one of the lowest total mill rates in the area. The current total mill rate is 36.486 mills.

The Cunningham—West Kingman County Board of Education has made facilities a priority in recent months. In 2020, the Board began discussions and formed a Facility Steering Committee consisting of parents, patrons, students and staff to evaluate educational programs, current buildings and their conditions, and to prioritize possible improvements to be considered for a capital improvement program. An architectural firm, a construction management firm, and bond finance experts were retained to help the Board and Committee. The Steering Committee considered renovation as compared to new construction and determined that new was a better long term investment for the district.

After numerous meetings, lengthy discussion, and consideration of many options, the Committee prioritized and made a recommendation to the Board of Education for a project and bond finance. The Board accepted their report and adopted a resolution that submitted a request to the State Board of Education for permission to place the question on the April ballot. In February, the State Board approved the request.

The proposed bond is more than just an educational issue. Communities are known by their schools, educational programs and to what degree education is a priority. Families and new businesses nearly always look at schools before making a decision as to where to relocate.

## **CHALLENGES**

- In a community and area like ours, our public schools are arguably our most important infrastructure asset.
- Quality education is difficult to accomplish in buildings that are outdated and inadequate.
- In USD 332, we have the opportunity and responsibility to provide education to about 210 students each year in our district.
- Unusual for Kansas rural districts, our enrollment has actually increased by more than 15% in recent years.
- The original 2-story Middle/High School building is more than 100 years old.
- Education and teaching have changed since this building was designed and constructed.
- With its age and much hard use, the building has significant physical and educational challenges.
- Limited space requires some teachers to share classrooms, limiting their effectiveness.
- The building also lacks space for today and tomorrow's changing curriculum.
- Science and FACS (Family & Consumer Science) classrooms are very outdated and inadequate.
- The library/media center located in the basement is considered inadequate.
- Mechanical and electrical systems are outdated and expensive to operate and maintain.
- Restrooms and other support areas are in need of major renovation or replacement.
- The separated shop building is too small and inadequate for this vital part of our curriculum.
- With agriculture being the core of our local economy, our schools need a dedicated and adequate area for students interested in agriculture and vocational education.
- The existing separate shop building lacks space for projects and storage.
- Existing storm shelter areas are considered poor and not accessible to the handicapped.
- The storm shelter area in the Grade School basement has windows that could spell disaster in a violent storm situation and also has no restroom facilities.
- Safety and security of students and staff must be priority and require improvements.
- The Grade School is considered structurally sound but needs some interior upgrades.
- Our USD 332 school buildings need expansion and improvements to prepare our young people for the future.



#### THE APRIL 5<sup>TH</sup> BALLOT QUESTION

Shall the following be adopted?

Shall Unified School District No. 332, Kingman County, Kansas (Cunningham—West Kingman County) issue general obligation bonds in an amount not to exceed \$13,245,000, to pay the costs to: (a) construct, equip and furnish a new high school building within the District including classrooms and support spaces, a shop area, storm shelter, and including furnishings and technology; (b) make improvements and renovations to the existing Elementary School within the District including, but not limited to, installation of air-conditioning (HVAC) to the gymnasium, providing necessary asbestos abatement, and improvements to office area fire suppression; (c) demolish the existing high school building and gymnasium lobby area to create space for the planned new construction; (d) make upgrades and improvements to security systems and parking areas at the District site; (e) make all other necessary improvements appurtenant thereto (collectively the "Project"); and (f) pay costs of issuance and interest on said general obligation bonds of the District during construction of the Project; all pursuant to the provisions of K.S.A. 10-101 et seq., K.S.A. 25-2018(f), K.S.A. 72-5457, and K.S.A. 72-5458 et seq.?

## **BOND ISSUE SOLUTIONS**

- Demolish the existing 2-story 1917 old high school and the gymnasium lobby area to make room for a portion of the planned new construction.
- The existing gymnasium would be retained.
- Construct, equip and furnish an area to infill the demolished old high school location to create a new Vo-Ag Shop, woods shop, Vo-tech classroom, Family & Consumer Science Lab, office suites, and a Media Center to also function as a FEMA standard storm shelter.
- Construct, equip and furnish an addition to the front of the retained gymnasium to create a new expanded lobby, restrooms, and concession area.
- Construct, equip and furnish a new wing for Middle/High School education with classrooms and support spaces including a new science lab area.
- Total new construction of approximately 34,000 square feet of modern, functional space.
- To not totally disrupt education, a phasing plan would see the new wing constructed first before the demolition to allow for minimal learning disruption.
- Make improvements and upgrades to the interior of the Grade School.
  - Install HVAC (Heating, Ventilation, and Air-Conditioning) in the gymnasium.
  - Provide fire suppression system improvements to certain areas of the Grade School.
  - Install improvements for enhanced safety and security at building entrances.
  - The outdated separate shop building would be repurposed for maintenance and storage needs.
  - Improvements to make teaching and learning more effective in our schools.
  - Improvements to make our schools safer and more secure for students and staff.
  - Improvements to help us to attract and keep quality teachers, staff, and students in USD 332.
  - attractive to families and businesses considering relocation to help our tax base and economy grow.
